FIELD TRIP BOARD OF DIRECTORS

The field trip below has been scheduled for the East Bay Regional Park District Board of Directors.

The field trip will commence at **9:30 a.m.** on **Thursday, September 9, 2010**, at EBRPD Headquarters, 2950 Peralta Oaks Court, Oakland, California. It is anticipated that the group will return to Headquarters at approximately **2:30 p.m.**

Depart Peralta Oaks **9:30 a.m.**
If anyone is planning to join the field trip at Peralta Oaks, they should arrive no later than 9:15 a.m.

Arrive at the McCosker Property, Sibley Volcanic Regional Preserve **10:00 a.m.**

The Board will be viewing the new land bank acquisition.

*[Note: Anyone who wants to join the field trip for the tour of the McCosker property should meet at the (green) residence gate at 9:45 a.m. The property is located at Pinehurst Road, Canyon. To reach the McCosker property: Going north (from Hayward) take 580 to Hwy. 13 (Warren Freeway), take Park Blvd. exit, turn left onto Mountain Blvd. about ¼ mile, turn right onto Snake Rd. about ¼ mile, keep right onto Shepherd Canyon Rd about 1½ miles to Skyline Blvd., go across intersection downhill onto Pinehurst Rd. approximately 2½ miles to residence gate.]

Arrive at Tilden Regional Park - Gillespie Group Camp **11:00 a.m.**

The Board will be viewing the near-completed restroom and fog shelter damaged in a fire, and the new ADA pathway.

[Note: Anyone who wants to join the field trip for the tour of the Gillespie Group Camp should meet at the campsite. To reach the camp: Right onto Pinehurst Road up to Skyline Blvd. about 2½ miles, right onto Skyline Blvd. about 1¾ miles to Grizzly Peak Blvd. about 2 miles, turn right to stay on Grizzly Peak Blvd about 5¾ miles, turn right onto South Park Drive; Gillespie Group Camp is on the left about ¼ mile.]

Arrive at Tilden Regional Park - Merry-Go-Round **11:30 a.m.**

The Board will view the patio paving project.

[Note: Anyone who wants to join the field trip to view the paving project should meet at the Merry-Go-Round. To reach the Merry-Go-Round: Left onto South Park Drive downhill about 1½ miles, turn left onto Wildcat Canyon Road about 2½ miles, turn right onto Central Park Drive about ½-mile to Merry-Go-Round parking lot on right.]

[Note: Anyone who wants to join the field trip for the presentation and tour should meet at the Youth Uprising Center. To reach the Center from Tilden Regional Park: Right on Central Park Dr. about 1¼ miles to Wildcat Canyon Road, left onto Wildcat Canyon Road about 2 ½ miles, turn right onto South Park Drive about 1½ mile uphill, turn left onto Grizzly Peak Blvd. about 3 miles, turn left onto Fish Ranch Road about ½ mile, turn left following signs to Highway 24 West, take Highway 13 East exit toward Hayward, merge onto Highway 580, exit Golf Links Road. Keep straight to 98th Ave. about ½ mile, turn right onto MacArthur Blvd. about ½ mile to Youth Uprising, 8711 MacArthur Blvd. on left.]
