## Trail Description

In 1987, the State directed the Association of Bay Area Governments to develop a plan for a non-motorized trail encircling San Francisco Bay. The Bay Trail provides accessible recreation opportunities for outdoor enthusiasts and access to commercial and residential neighborhoods. It offers spectacular wildlife viewing and improves public awareness and respect for the bay. It also provides important transportation benefits, providing a commute alternative for pedestrians and cyclists and a connection to numerous transportation facilities.
