STATE OF CALIFORNIA CRIME VICTIM COMPENSATION PROGRAM

- Relocation for your safety
- Home security
- Lost income

SEXUAL ASSAULT

Sexual assault by a person who is known to the victim, including sexual assault by a person who is the spouse of the victim, is a crime. If you are a victim of sexual assault, go to a safe place and call police. Do not clean up any physical injuries or trauma until you speak to police.

CIVIL LIABILITY

You have the right to file a civil suit for loses suffered as a result of the abuse. This may include medical expenses, loss of earnings, and other expenses for injuries sustained and damage to property, and other expenses incurred by the victim or an agency that shelters the victim.

Domestic violence or assault by a person who is known to the victim, including a spouse, is a crime. If strangulation occurred, you may be at risk of internal injuries and are encouraged to seek medical attention.

POLICE PROTECTION

A. OFFICER ARREST (836 PC)

The East Bay Regional Park District Police Department is committed to protecting the persons who are the victims of domestic violence. Officers may arrest the offender when probable cause exists, and take the offender to jail.

B. CITIZEN'S ARREST (837 PC)

In certain cases, officer's cannot make an arrest themselves, but you, as a victim, may make a citizen's arrest. The officer will inform you about how to arrest the offender. In most cases, the officer will be able to take the offender to jail.

C. CITATION AND RELEASE (853.6 PC)

If the officer determines there is not a reasonable likelihood the offense will continue, or the safety of persons or property would not be imminently endangered by release of the person arrested, the officer may cite and release him/her. Despite official restrain of the offender, the offender may be released from detention at any time.

If the subject was arrested it is not a guarantee of victim safety. The subject may be released from custody by bond or some other form of release.

D. COURT RESTRAINING ORDERS

If you have obtained a Restraining Order which stops the offender from beating, harassing and abusing you, and the offender knowingly violates the order, he/she will be arrested, and in most cases taken to jail. MAKE SURE THE OFFENDER HAS BEEN SERVED A COPY OF THE ORDER.

RESTRAINING ORDER INFORMATION

Who can obtain a restraining order? Anyone who has been threatened, harassed, abused or assaulted.

<u>How much does it cost?</u> There is no court fee for restraining orders resulting from violence.

Serving the defendant. Any adult, not a party to the action, may serve the offender/defendant, but before making that decision, the threat of violence should be considered. You can request a fee waiver from the Judge and ask the Sheriff's Office Civil Division to serve the defendant.

What can the restraining order do? Direct the attacker to leave the household; prevent the attacker from entering the residence, school, business, or place of employment; award custody of or visitation of children; refrain the attacker from molesting or interfering with custody of minor children; direct the party not granted custody to pay support of minor children if that party has a legal obligation to do so; direct the defendant to make specified debit payments coming due while the order is in effect; direct that either or both parties participate in counseling; restrain the attacker from abusing the victim and other family members.

What to do if the restraining order is violated?

- 1) Call police having jurisdiction where the violation of the restraining ordered occurred.
 2) Ask that formal report be taken. 3) When a violation of a domestic violence restraining order occurs, the violator shall be arrested.
- Emergency Protective Order (EPO) If you are in immediate threat of danger, you may request an EPO from the police. EPOs are issued when the court is not in session. There is no charge and it is valid for 5 court days after it is issued.
