

DIVISION 01: PAINTING AND STAINING

01.01 GENERAL

- .1 THE GENERAL CONDITIONS AND THE SUPPLEMENTARY CONDITIONS SHALL APPLY TO ALL OF THE WORK OF EVERY DIVISION, SECTION, OR SUBSECTION OF THESE SPECIFICATIONS AS IF FULLY REPEATED IN EACH.
- .2 SUMMARY OF WORK: PROVIDE ALL MATERIALS, LABOR AND EQUIPMENT NECESSARY TO COMPLETE ALL WORK AS SHOWN ON THE DRAWINGS AND AS SPECIFIED HEREIN, INCLUDING, BUT NOT LIMITED TO, THE FOLLOWING:
 - a. STAINING OF WOOD (EXAMPLES: NEW 1-RAIL AND 2-RAIL WOOD FENCES AND PLANK GATES).
 - b. PAINTING OF WOOD (EXAMPLES: PREVIOUSLY PAINTED OR STAINED WOOD SUCH AS PICNIC TABLES, BENCHES OR FENCES).
 - c. PRIMING AND PAINTING OF METAL (EXAMPLES: METAL PIPE GATES, ENTRY GATES, BOLLARDS, AND STORAGE SHEDS/CONTAINERS).
 - d. TOUCH-UP PRIMING AND PAINTING OF METAL.

01.03 WORKMANSHIP

- .1 WORKMANSHIP SHALL BE OF A "FIRST-CLASS" QUALITY AND CONSISTENT WITH INDUSTRY STANDARDS AND MANUFACTURER'S INSTRUCTIONS.
- .2 SURFACE PREPARATION, APPLICATION, SAFETY PRECAUTIONS, AND CLEANUP SHALL BE IN CONFORMANCE WITH THE COATING MANUFACTURER'S INSTRUCTIONS, UNLESS SPECIFIED OTHERWISE.
- .3 METAL SHALL BE PRIMED PRIOR TO PAINTING. PRIMER SHALL BE AS SPECIFIED HEREIN, AND APPLIED IN A MINIMUM OF ONE (1) COAT, IN CONFORMANCE WITH THE MANUFACTURER'S INSTRUCTIONS, UNLESS SPECIFIED OTHERWISE.
- .4 PAINT AND STAIN SHALL BE APPLIED IN A MINIMUM OF TWO (2) COATS, IN CONFORMANCE WITH THE MANUFACTURER'S INSTRUCTIONS, UNLESS SPECIFIED OTHERWISE.
- .5 EACH COAT OF PRIMER, PAINT OR STAIN SHALL BE APPLIED AT PROPER CONSISTENCY AND BRUSHED EVENLY, FREE OF BRUSH MARKS, SAGS, RUNS, WITH NO EVIDENCE OF POOR WORKMANSHIP. FINISHED PAINTED OR STAINED SURFACES SHALL BE FREE FROM DEFECTS OR BLEMISHES.
- .6 FOR TOUCH-UP OF METAL, SURFACE PREPARATION, APPLICATION, SAFETY PRECAUTIONS, AND CLEANUP SHALL BE IN CONFORMANCE WITH THE MANUFACTURER'S INSTRUCTIONS, UNLESS SPECIFIED OTHERWISE. PRIMER SHALL BE APPLIED IN A MINIMUM OF ONE (1) COAT, AND PAINT SHALL BE APPLIED IN A MINIMUM OF TWO (2) COATS.
