The field trip below has been scheduled for the East Bay Regional Park District Board of Directors, and will commence at 10:00 a.m. on **Tuesday, June 21, 2016, at the Big Break Visitor Center at the Delta, 69 Big Break Road, Oakley, California.** It is anticipated that the group will return by approximately 12:15 p.m.

Meet at the Big Break Visitor Center at the Delta **9:30 a.m.**
(Anyone planning to join the field trip at Peralta Oaks should arrive no later than **8:15 a.m.** The group will **not** return to Peralta Oaks at the end of the tour.)

Depart from Big Break Visitor Center for Contra Loma **10:00 a.m.**
From Big Break Visitor Center, take Big Break Road to Main Street and turn right. Proceed to Highway 4 and turn left toward CA-4 W. Take Exit 28 onto Lone Tree Way, A Street. Turn left onto A Street toward Lone Tree Way. Turn Right onto Golf Course Road. Turn right onto Frederickson Lane and proceed into Contra Loma Park to meet at the Contra Loma Boat Launch area.

Arrive at Contra Loma Park - Boat Launch Area **10:20 a.m.**
The Board will be visiting the Contra Loma boat launch area where Civil Engineer, Shun Yu and Grants Manager, Tiffany Margulici will be talking about the upcoming boat launch project that will be developed in the coming years. We will also view and discuss some of the water efficiency projects that have been completed throughout the park.

Depart Contra Loma for the Nunn Property, Oakley **11:00 a.m.**
Leave Contra Loma Park for the Nunn Property, 9054 Byron Highway, via Fredrickson Lane. Turn Left on Golf Course Road. Turn Right on Lone Tree Way. Turn Right on Brentwood Boulevard. Turn Left on Sunset Road. Turn Left on Byron Highway. The Nunn Ranch House will be on the right, just past Eagle Lane.

Arrive at the Nunn Property, Oakley **11:30 a.m.**
The Board will visit the newly acquired 645 acre Nunn Property in Brentwood, where Suzanne Lusk, Land Acquisition Specialist, will give an overview of the property's current and future development as part of the Delta Access.

Depart Nunn Property to Return to Big Break Visitors Center at the Delta **12:00 p.m.**
Leaving the Nunn Property, Turn Right on Byron Highway. Turn Left on Delta Road. Turn Right on Main Street. Turn Right on Big Break Road.
