***Depart Peralta Oaks** **10:00 a.m.**
(Anyone planning to join the field trip at Peralta Oaks should arrive no later than **9:45 a.m.**)

****Sunol Regional Wilderness** **11:00 a.m.**
The Board will be touring the new bridge at Sunol. Lunch will be served at the Sunol Visitors Center at 12:00 p.m.

From Peralta Oaks, take CA 580E towards Hayward. Take Hwy 680S towards Sunol, then exit at Calaveras Rd/Highway 84 just south of the town of Sunol. Turn left onto Calaveras Rd. and proceed 4 miles to Geary Rd. which leads directly into the park. The bridge is at the far end of the parking area.

Vargas Plateau Regional Park **1:30 p.m.**
The Board will meet at the first turnout on Morrison Canyon Rd to view the location of the New Staging Area.

From Sunol Park, go back out Geary Rd. Make a right turn onto Calaveras Rd. Stay on Calaveras Rd. for 4 miles, then turn left onto Highway 680S towards Fremont. Exit at Vargas Rd. and make a right turn at the bottom of the off ramp. Stay on Vargas Rd. until it merges with Morrison Canyon Rd and bear right onto Morrison Canyon Rd. We will meet at the turnout in front of the old barn on the left.
