Depart Peralta Oaks **10:00 a.m.**

From Peralta Oaks, take I-580 West towards the Richmond-San Rafael Bridge. Take the last exit before the Toll Plaza on Stenmark Drive. At the 3-way fork in the road take the far left road. We'll stop at the bottom of the road (Caltrans Staging Area) to re-group.

Arrive at Point Molate Bay Trail **10:45 a.m.**

The Board will drive and walk out as far as possible on this planned trail and hear from Trails Development Program Manager Sean Dougan and Ryan Schaefer from Nichols Consulting Engineers on the proposed trail plan.

Note: Those who would like to walk will have ample opportunity; for those with mobility challenges, drivers will be available to transport people to the Point Molate Beach Park parking area.

Arrive at Point Molate Beach Park **12:00 p.m.**

The hikers and riders meet here. Small presentation on the history of the area.

Drive to Miller/Knox Regional Shoreline Park **12:30 p.m.**

Exit parking lot onto Stenmark Drive. – **1.2 miles**

Merge onto I-580 East onramp; get in the right lane. – **0.8 miles**

Take the Canal Blvd. exit toward Garrard Blvd. – **0.3 miles**

Turn **left** onto Canal Blvd. – **0.3 miles**

Sharp/acute **left** onto S. Gerrard Blvd and follow – **0.8 miles**

* Note: Street name changes to Dornan Dr. on the other side of the tunnel.

Follow Dornan Dr. to the Miller/Knox South parking lot. – **0.4 miles**

** Please park near the end of the lot.

Arrive at Killdeer picnic site, Miller/Knox Park - 12:45 p.m.

**Lunch at picnic site. Bob Nisbet to speak; Sean Dougan to discuss Chevron Agreement for Easement Donation Status/Challenges

Drive back to Peralta Oaks 2:00 p.m.

Arrive at Peralta Oaks 2:45 p.m.
