Please note: Due to the scheduled Board meeting following the field trip, transportation from the EBRPD Administration Building and lunch will not be provided.

Depart from Big Break 9:00 a.m.

From Big Break Visitor Center turn left onto Big Break Rd, continue 0.25 miles, then turn right onto Main St., travel 1.25 miles then turn left onto Hwy # 160 south on ramp towards Hwy # 4, continue 0.75 miles then merge right onto Hwy # 4 west, continue 2.5 miles then exit at Lone Tree Way/ A Street off-ramp, turn left onto Lone Tree Way, continue 1.5 miles then turn right onto Golf Course Rd., continue 1 mile then turn right onto Mesa Ridge Dr., continue 0.25 miles to Empire Mine Rd. (note Empire Mine Rd. is closed to private vehicles, anyone wishing to join this part of the tour will need to be in a district vehicle) the Board will continue 2.4 miles on Empire Mine Rd. to Horse Valley.

Arrive at Horse Valley 9:25 a.m.

The Board will gather and hear a presentation on the proposed Wetland Restoration Project from Project Coordinator Karla Cuero and Executive Director of the ECCCHCP Abby Fateman. Following the presentation, the Board will continue to the former Roddy Ranch Golf Course.

Depart from Horse Valley 9:55 a.m.

From Horse Valley continue 1.3 miles on Empire Mine Rd., turn right onto Deer Valley Rd., continue 0.4 miles and turn right onto Tour Way, continue 0.7 miles to the parking lot.

Arrive at Roddy Ranch Golf Course 10:10 a.m.

The Board will gather and hear from Chief of Planning Brian Holt on potential park planning for the Deer Valley area. The Board will also hear from acting Chief of Land Acquisition Michael Reeves on the acquisition history of the area. After these presentations the Board will continue to the Roddy Home Ranch.

Depart from Roddy Ranch Golf Course 11:00 a.m.

Take Tour Way 0.7 miles and turn right onto Deer Valley Rd., continue 0.7 miles and turn right onto Chadbourne Rd., continue 1 mile to the Roddy Home Ranch, turn left into the parking area.

Arrive at Roddy Ranch Home 11:10 a.m.

The Board will gather and hear from Regional Services Manager Ira Bletz on the potential of future interpretive uses at the Roddy Home Ranch. After this presentation the Board will return to the Big Break Visitor Center.

Depart from Roddy Ranch Home 11:40 a.m.

Turn right onto Chadbourne Rd., continue 1 mile and turn left onto Deer Valley Rd., continue 0.5 miles and turn right onto Balfour Rd., continue 2.5 miles and use the left two lanes to turn left onto Hwy # 4, continue 4.8 miles and take the exit for Hwy # 160, continue 0.6 miles and take the CA-4 exit toward Stockton/Oakley, continue 0.3 miles and turn right onto Main St., continue 1.1 miles and turn left onto Big Break Rd., continue 0.3 miles and turn right into parking area for the Big Break Visitor Center.

Arrive at Big Break Visitor Center & Adjourn 12:00 p.m.
