The Public hearing will be facilitated by the Clerk of the Board, and the chair of the Finance Committee, Director Beverly Lane. Today the actions are to hold a noticed public hearing, and to approve the resolution of formation. Following the election, the Board will go back and approve the ordinance to levy the taxes.
