The field trip below has been scheduled for the East Bay Regional Park District Board of Directors, and will commence at **10:00 a.m. on Friday, September 11, 2015**, at the EBRPD Administrative Office, 2950 Peralta Oaks Court, Oakland, California. **Anyone planning to join the field trip at Peralta Oaks should arrive no later than 9:45 a.m.** It is anticipated that the group will return by approximately 3:15 p.m.

Depart Peralta Oaks

10:00 a.m.

From P.O. turn right on Peralta Oaks Drive, turn left on 106th Avenue, turn left onto Foothill Blvd., turn left onto Macarthur Blvd., and merge onto I-580 E via the ramp toward Hayward. Travel approximately 15 miles on I-580 E, then merge onto I-680 S toward San Jose. In 4 miles exit at Castlewood Dr. and turn right onto Castlewood Dr. Turn left onto Foothill Road, towards the town of Sunol. The Foothill Staging Area is about two miles down, on the right.

Arrive at Pleasanton Ridge / Foothill Staging Area

10:30 a.m.

At the Foothill staging area we will gather to get oriented to the park and talk about current use patterns and conditions within the park. We'll depart at 10:45 a.m. and drive up internal park trails to the site of the Road to Trail conversion site.

The park tour will be conducted in District vehicles. **Personal vehicles must be parked in the parking lot** before proceeding into the park in District Vehicles. District vehicles will caravan to a viewing areas.

Travel to Road to Trail Conversion

11:00 a.m.

The group will hike the Road to Trail conversion project completed in 2014 and hear about how this project was accomplished.

Depart from Ridgeline Trail and travel through the park to staff office at Garms.

Arrive at GARMS for Lunch

12:15 p.m.

Depart Garms and travel to Tyler Ranch

1:00 p.m.

From the staff office at Garms exit on River Rock Hill Rd., turn right onto Foothill Road and proceed south to 12566 Foothill Road in Sunol. Approximately 5.6 miles.
