The field trip below has been scheduled for the East Bay Regional Park District Board of Directors, and will commence at 9:30 a.m. on **Friday, September 12, 2014**, at EBRPD Administrative Office, 2950 Peralta Oaks Court, Oakland, California. It is anticipated that the group will return at approximately 3:00 p.m.

***Depart Peralta Oaks** **9:30 a.m.**
(Anyone planning to join the field trip at Peralta Oaks should arrive no later than **9:15 a.m.**)

Arrive Spencer Property (Land Bank Crockett Hills) **10:30 a.m.**
The Board will be touring this recently opened land banked property off of DePeru Drive, high up in the Crockett Hills. They will meet with Naturalist, James Wilson, and park staff to discuss site history and current park operations.

From Peralta Oaks, take CA 580W towards Downtown Oakland. Keep left and take I-80E towards Vallejo/Sacramento. Take the Pomona Street exit (Exit 27) toward Crockett. Turn left, then turn right onto DePeru Drive. Proceed to top of the hill. The road will dead end into the Spencer Property.

Arrive TXI (Brickyards – Port Costa) **** (Lunch) 11:30 a.m.**
The Board will be met by Jim Townsend, Project Manager and Mike Berger, Resident Engineer - Parsons Brinckeroff. Jim Townsend will give an overview of the Park Districts’ acquisition and funding of this Bay Trail Project. Mike Berger will give an overview of the engineering and construction of this project. The Board will be eating lunch directly following these short presentations. Following lunch, depending on construction progress, Mike will lead a short driving tour of the Bay Trail.

From DePeru Road, return to bottom of the hill and turn right onto Carquinez Scenic Drive for about five miles to the proposed staging area for TXI/Brickyard. Turn left and enter the staging area.
