PROJECT TITLE: PLEASANTON RIDGE REGIONAL PARK LAND USE PLAN (LUP)

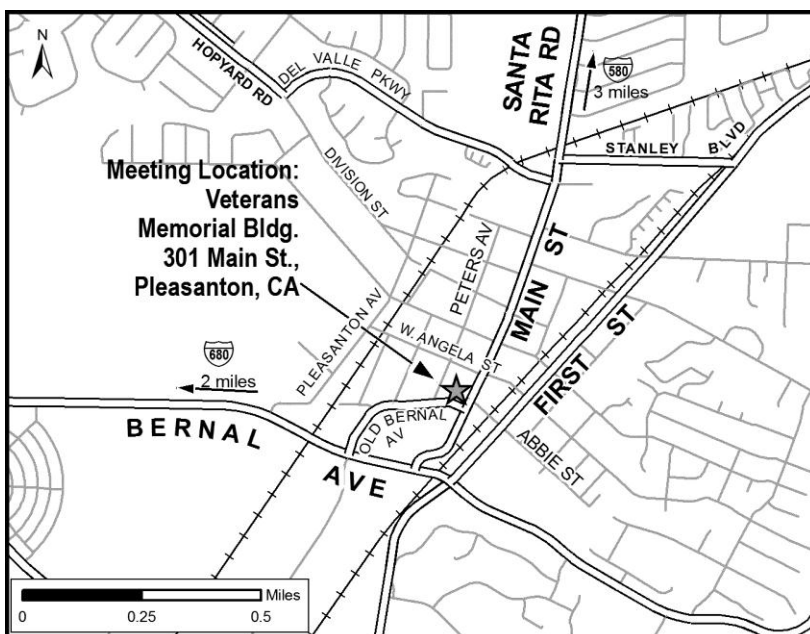
PROJECT LOCATION: Multiple jurisdictions, Alameda County, California

PROJECT DESCRIPTION: The LUP has been prepared to identify: 1) public access and recreation and staff service facilities and programs; and 2) natural and cultural resource management programs. Implementation of the LUP will expand public access, trails and low-intensity recreational opportunities, while ensuring the long-term conservation of the land's natural and cultural resources (see reverse for project details).

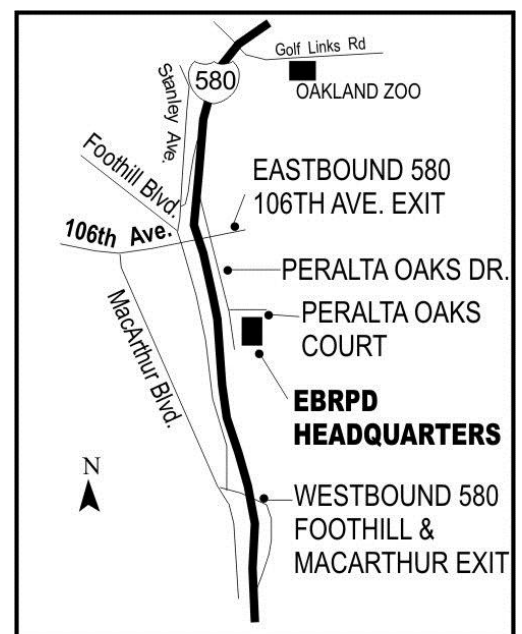
