The purpose of this statement is for you to identify your qualifications in specific job-related areas. It is important that you fill out this form thoroughly and concisely. You are welcome to attach a resume, but not in substitution for this supplemental statement. Please limit your responses to no more than (3) pages; not counting question #11. When describing your experience in the following areas, first indicate the job where you gained the experience by referring to #11 of the application form and identifying that job by letter (a, b, c, d, or e), then bring out those aspects of your experience that have relevance for this position.

1. Select the job from your application where you had the most relevant experience operating and repairing farming equipment. Describe the equipment, application, your responsibilities, how often and number of operation (hours per week, month or year) and types of repairs.
2. Select the job from your application where you had the most relevant experience with crop management, i.e., crop selection such as corn, wheat, potatoes, vetch, hay, nut orchards, alfalfa, and soybeans; field location and rotation needs; soil analysis, etc.
3. Select the job from your application where you had the most relevant experience with animal husbandry, specifically, livestock and farm animals (e.g pigs, horses, sheep, cows, poultry, game birds) and describe your responsibilities particularly including vaccinations, dehorning, assisting in birthing, and breeding
4. Select the job from your application, where you had the most relevant construction experience, i.e., building or repairing: fences, corrals, shelters, feeding and watering systems. Describe the activity(s), size/extent of project(s), type of animal (s) or equipment housing; your responsibilities; how often and number of hours with this type of work (hours per week, month or year).
5. Select the job from your application, where you had the most relevant experience with antique equipment, and/or horse-drawn farming. Describe your responsibilities.
6. Select the job from your application, where you had the most relevant experience working with draft horses or other equine. Describe the activity(s), type of animals(s), your responsibilities, how often and number of hours with this interaction (hours per week, month, or year).
7. Select the job from your application and describe what your responsibilities were relative to ability to lead and instruct others either employees and/or volunteers in assisting in program delivery, breeding, crop and/or orchard management, and equipment use and maintenance?
8. Select the job from your application where you had the most relevant experience with record keeping, purchasing, computer skills, public relations or public speaking, and describe your responsibilities.
9. List any professional and/or vocational organizations or clubs (related to this position) that you have belonged to, and the dates of your membership.
