She also stated that in exchange for its contribution, EBRPD will acquire a conservation easement over the entire property. Muir Heritage Land Trust (MHLT) plans to expand the trail system from Fernandez Ranch onto this property. Ms. Wenninger clarified that MHLT will own and manage this property; the District's sole responsibility will be to monitor and enforce the conservation easement.

Mr. Linus Eukel, MHLT Executive Director, added that the proposed trail system will ultimately go across Highway 4 and serve as a connector to not only Crocket Hills Regional Park but also to Carquinez Bridge. He expressed his gratitude to the Board as well as District staff for their support and collaboration in moving this item forward.

C-2-b. Authorization to Execute the Option, Purchase and Sale Agreement and to Transfer Funds for the Acquisition in Partnership with the East Contra Costa County Habitat Conservancy of the 1,021± acre Souza III Property: Byron Vernal Pools Regional Preserve Resolution No. 2010 – 6 - 161 (attached)

Nancy Wenninger, Land Acquisition Manager provided a presentation on this item. She stated that this acquisition includes the existing 31 wind farm leases and 3 cell sites on the property which generate about \$315,000 per year. Through an agreement with the ECCHC, the revenue will be used for 1) management of land within the Vasco Road corridor; 2) to set up an endowment to pay for future management; and 3) provide for matching funds for future acquisitions in the area.

In response to a question by <u>Director Sutter</u>, Ms. Wenninger stated that the annual revenue for the wind farms is about \$250,000 for the next seven years and is scheduled to increase thereafter; the revenues will depend on the actual amount of electricity generated. She added that the current lease is good for another 17 years, with the lease holders having an option to renew for another 10 years; therefore, a decision as to whether to renew or not will not be needed for another 27 years.

The Board of Directors expressed its appreciation to the Souza family for their cooperation with the District.

#### 3. SPECIAL PRESENTATION

# C-3-a. John Kopchik, Executive Director, East Contra Costa County Habitat Conservancy

Bruce Connelly, Chair of the East Contra Costa County Habitat Conservancy (Conservancy), introduced John Kopchik, Executive Director of the Conservancy, who provided an update on the East Contra Costa County Habitat Conservation Plan/Natural Community Conservation Plan (ECCC HCP/NCCP) – Implementation, Land Acquisition, Habitat Restoration, Funding and On-going Partnership with the East Bay Regional Park District. Mr. Kopchik stated that the ECCC HCP/NCCP is essentially a conservation and mitigation plan for endangered species, but was also carefully written to be a conservation plan that works for recreation. He added that it is the first of its kind approved in Northern California, and would not have been possible without the cooperation of the East Bay Regional Park District. Mr. Kopchik spoke briefly about the history and milestones in the development of the HCP, as well as various restoration projects. The funding overview for the 5,042 acres purchased in partnership with the District is as follows:

Mr. Anderson stated that he anticipates to have the dedication in 2011. Rick Parmer, Chief of Interpretation and Recreation, gave a brief overview of the science and education aspects of the Delta Science Center, stating that District staff had worked with Friends of Marsh Creek to develop the initial concept for the area and are currently working towards the development of an "exhibit concept" plan. He added that staff is also looking at other funding opportunities to help pay for the exhibits.

<u>Tom Lindemuth</u> of the Delta Science Center thanked the Board for its leadership in bringing the Delta Science Center facility to the level that it is in now. He gave a brief presentation on the various citizen- scientist activities at Big Break.
