From Peralta Oaks, take I-580 East, travel approximately 25 miles and exit onto N. Vasco Road (exit #55), follow N. Vasco Road 16 miles and turn right onto Camino Diablo, travel 1.7 miles on Camino Diablo and then turn right onto Byron Hwy (J-4), follow the Byron Hwy 1.4 miles and turn right onto Byron Hot Springs Road, travel 0.3 miles and the entry to Byron Hot Springs will be on the right side of the road at 5400 Byron Hot Springs Road.

Arrive at Byron Hot Springs **11:00 a.m.**

Board will gather and hear from Chief of Acquisition Liz Musbach about the potential acquisition of this parcel. The Board and group will tour the property. Depart Byron Hot Springs at 12:00 p.m.
