Turn right on Main Street and follow past the Ferry Terminal to the end of the street. Parking lot is located at on Navy Way. Park staff will wait at the gate for everyone to gather.

Least Tern Colony Nesting Area

The Board will hear from Biologist Susan Euing with US Fish and Wildlife Service about the Least Tern nesting area.
