Depart Peralta Oaks **9:30 a.m.**

From Peralta Oaks Court, take I-580 east to Livermore, exit at Vasco Road. Proceed on Vasco Road south. At the end of Vasco Road turn right onto Tesla Road. Proceed on Tesla Road to the next light. Turn left onto Mines Road, continue straight on Del Valle Road and up the hill to the Del Valle entry Kiosk. After kiosk, head straight and go over the bridge and turn left after the bridge. Follow the campground entrance road and turn left into the campground. Parties will stage at the campground store parking area across from the campground kiosk.

Arrive at Del Valle Park ~ Del Valle Campground **10:30 a.m.**

The Board will tour the convenience camping cabin site and hear from Lakes Unit Manager Jeff Manley and Administrative Analyst II Nate Luna about the project. The Board will be provided with updates on the upcoming campground bathroom building replacements.

Depart the parking lot and proceed back to the intersection at the bridge. Continue straight at the intersection to the west side of the park and turn right at the first parking area.
