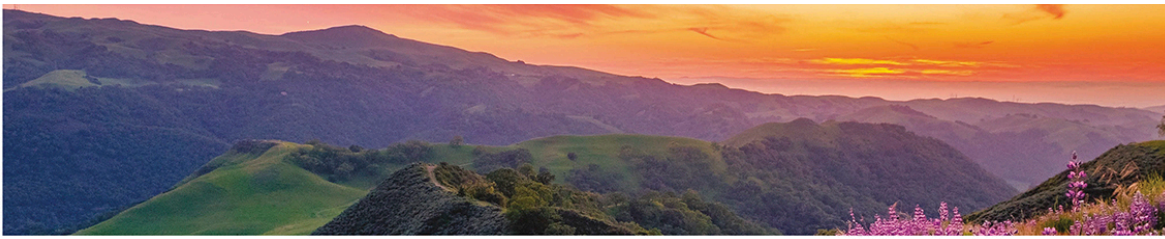

SUBJECT: Park Operations Parkland Unit Update: Trail Maintenance in the Wildcat Creek Watershed

Parkland Unit Manager Dan Sykes will present an introduction to trail and watershed maintenance issues within the Parkland Unit. The parks in the Oakland and Berkeley Hills are experiencing record high park attendance and trail use, while dealing with aging infrastructure and trails, recent storm damage, and increasing regulatory oversight regarding watershed health. As an example of the innovative work that staff is undertaking to address trail maintenance within these constraints, Park Ranger Darren Bresee will then present a multi-year project that he has been leading to improve the quality of the Wildcat Gorge Trail in Tilden Regional Park. The project’s overall approach blends the importance of improving watershed health without detracting from the user experience of park visitors. Darren will also provide an overview of bootleg trail remediation.

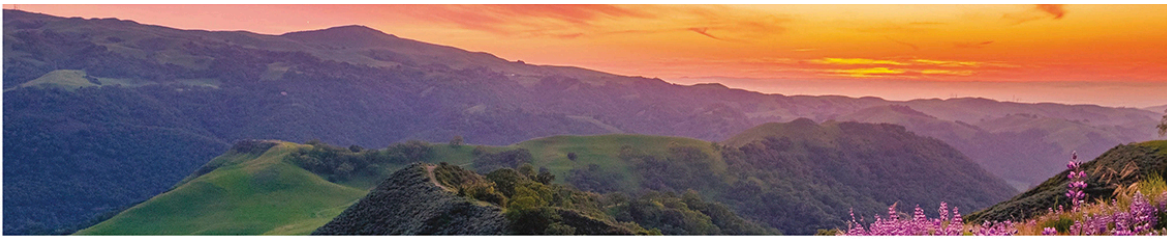
