- 1 session of Camp of the Wild at Tilden (Berkeley)
- 1 session of Tilden Little Farm Camp at Tilden (Berkeley)

### How to Apply For “Campership” Financial Aid

1. Complete the Application Form. Incomplete applications *will not* be processed and will be returned to you.
2. Applicant must reside in **Alameda or Contra Costa County** with child(ren) between six months and 17 years old.
3. Application must be accompanied by current supporting documentation (see application)
4. Application must be received at least 14 days before registration ends.

5. Notice of approval of application will take place within two (2) weeks of receiving your complete application. Registration can only occur after application is approved and all remaining fees are paid.
6. If you are notified that you are eligible to receive “Campership” financial aid, **YOU must register your child in an open course and pay the co-pay.**
