

## 2023 FINANCIAL AID “CAMBERSHIP” APPLICATION INSTRUCTIONS

The East Bay Regional Park District in partnership with the Regional Parks Foundation provides financial aid “campership” opportunities to qualifying youth for select summer programs. Funding is limited and financial aid is offered only after a complete application is received and reviewed. The applicant will be notified via **email** of the status of their application 7-10 days after initial submission. Applying does not guarantee funding nor a space in a program. An approved campership application must be on-file BEFORE registering for program(s).

### INSTRUCTIONS:

1. Fill out **ALL** required fields. Incomplete or illegible forms will be returned. Applicant must reside in Alameda or Contra Costa County. Proof of residency may be requested in addition to supporting documentation.
2. Provide **ONE** of the following **CURRENT** supporting documents:
  - CalWorks
  - SNAP (Supplemental Nutrition Assistance Program)
  - SSI (Supplemental Security Income)
  - SSDI (Social Security Disability Insurance)
  - Foster Care Certification (letter of determination)
  - Referral Letter from: Acta non Verba, Lincoln Child Center, Monument Crisis Center, YES to Nature-to-Neighborhoods, or Brothers-on-the-Rise.
  - 2022 Tax Transcript (from <https://www.irs.gov/individuals/get-transcript>) meeting HUD Very Low-income limits for Alameda and Contra Costa County shown below.
