Trail Description

Since the 1970s, the Calaveras Ridge Regional Trail is one of the originally designated regional trail corridors in the Park District Master Plan. This multi-use trail corridor travels along the I-680 corridor connecting six regional parks. It serves communities from Sunol Regional Wilderness, through Pleasanton Ridge to Dublin Hills into Contra Costa County where it continues through Las Trampas Regional Wilderness to the City of Lafayette through Briones Regional Park, with connections to Carquinez Strait. This trail offers spectacular views of San Francisco Bay area to the west and Mt. Diablo and the central valley to the east along rolling ridgetops.
