Trail Description

Established in 1986, this multi-use trail follows the Southern Pacific Railroad right-of-way established in 1891 and abandoned in 1977. The completed Iron Horse Regional Trail will span the distance from Livermore in Alameda County to Suisun Bay in Contra Costa County a distance of over 55 miles connecting two counties and nine communities.

The trail corridor connects residential and commercial areas, business parks, schools, public transportation, regional trails and community facilities. Throughout its entire length, opportunities to view the valley ridgeline and landscape features like Mt. Diablo create a pleasant trail experience.
